Must have legal name (Modern)

Kingdoms & groups may continue require pre-registration at their discretion

Currently only outdoor practice/events allowed  
This is a kingdom decision

Pre-registration

Not required for practices or small local gatherings  
Required for events

Sign in Rosters

Need modern name  
Method by which to contact individual

Masks

Some ppl that are vaccinated may choose to continue to wear  
This is okay  
Wear one if not vaccinated

Vaccinations

Not allowed to ask about at official SCA activities  
Individuals can ask for info about

Food

For time being food & water not shared  
Pending July BOD mtg  
Food sharing may be allowed  
If prepared using COVID safe practices  
Everything individually sealed  
Water may be shared via cooler  
If no one touches cup to spigot  
Or drinks straight from cooler  
Have someone to supervise coolers  
An individual may share food  
This is on a private basis  
Person accepts at their own risk (not SCA sanctioned)

Cooking competitions

Prepare food using COVID safe practices

Person competing serves food to judges only

COVID warning language

"Although the SCA complies with all applicable laws to ensure the health and safety of our event participants, we cannot eliminate the risk of exposure to infectious diseases during in-person events. By participating in the in-person events of the SCA you acknowledge and accept the potential risks. You agree to any additional steps to protect your own health and safety and those under your control as you believe to be necessary"

If placed at gate- be sure to verbally point out

Ideally posted at all activities

Must be visible to those wandering by

Can point it out as people sign in

Requirement for publishing has been reinstated

If have events in Sept onward- get in articles post haste

Gate

"Someone at each event needs to have a Financial Warrant. The Seneschal can be that person if the Exchequer (or their warranted deputy) is not there, but does not require a separate warrant. This person is responsible for gate oversight and reconciliation. This person is not required to sit at gate, but MUST be available if the need arises. Anyone taking/handling money must be a paid SCA member, but not necessarily warranted. A log/roster must be maintained for these individuals and should include name (mundane and SCA), contact info, state ID and membership number. Other gate personnel do not need to be paid members, but then can not handle money either. PayPal Swipers are required to be warranted and trained by Kingdom."

SCARS

Society for Creative Anachronism Registration System

Method by which can pre-register and pre-pay (using CC/PP)
