Late fees are waived until further notice b/c COVID

Payment= check, CC, or PayPal

01 April 2021 (BOD mtg 23 March 2021)

Resolution to lift suspension of in-person activity effective 1st June 2021

Must follow all province, territory, state, & local guidelines at SCA events

Masks (fully cover nose & mouth) worn by those age 4 and up at all times (eat/drink exception)

Also worn during all activities requiring voice projection (recommend voice amplification devices)

Attendees must provide own food/drink

When eat/drink follow social distance + remain stationary

No overnight camping

All events

Held outdoors

Max 150 people

Pre-registration is required (Society is providing Event Module)

If want to open early or deviate from aforementioned restrictions

Request a variance from Society Seneschal

Small local gatherings

Examples: guild meetings, officer meetings, marital activities

Discretion of Crown & Kingdom Seneschal

According to local guidelines

Virtual events still good option

This is only first step

Continually assessing

Will make changes as needed (either add or relax restrictions)

Regardless of safety precautions

Keep educated about risk to self and loved ones

Make responsible choices to protect

28 March 2021- From Kingdom Seneschal

Re-opening

Use local info for data-driven decision

Will determine system for reporting infections prior to re-open

Kingdom & local groups will work in tandem

Will be done in phases

Practices= reoccurring, regular gatherings

Events= one time gatherings

Gated Phase

No in person events/practices

Phase 1

Masks & social distancing of 6 feet

Must petition kingdom to hold

Include current, local, mandated requirements

At the gathering

Local seneschal or rep will take temps

Ask if have flu-like symptoms

Obtain contact tracing info

Ask attendees to report on health

If have flu-like symptoms within next 2 weeks

Bimonthly COVID reports sent to kingdom

Outdoor Practices

Petition kingdom to open

Allowed based on 2X requirement

If practice attendance # before COVID= 20

Must wait until local gathering limits= 40

If during practice # in attendance would exceed limit

Practice is terminated

Splitting of practice is not allowed

Indoor Practices

Petition kingdom to open

10 people or less (per local guidelines)

Attendance exceeds limit

Termination

Phase 2

Masks & social distancing of 6 feet

Local seneschal notify crown/kingdom seneschal having practices

Must petition to hold events (include local guidelines)

At event

Local seneschal or rep will take temps

Ask if have flu-like symptoms

Obtain contact tracing info

Ask attendees to report on health

If have flu-like symptoms within next 2 weeks

Monthly COVID reports sent to kingdom

Outdoor Practices

Local seneschals to open

Local guidelines allow sufficient #s for practice

If during practice # in attendance would exceed limit

Practice is terminated

Splitting of practice is not allowed

Indoor Practices

Allowable

Local guidelines allow sufficient #s for practice

If during practice # in attendance would exceed limit

Practice is terminated  
Splitting of practice is not allowed

Events

Small are allowable  
Must petition to hold (include local guidelines  
150 ppl or less (per local statutes)

Phase 3

Same as Phase 2  
Contact tracing (sign in)  
Reporting  
From attendees if flu-like symptoms within 2 weeks  
COVID report by local seneschal to kingdom

Difference=

Larger # of people  
Social distance, masks, other precautions  
Determined by local guidelines  
No petitions to hold practices nor events

Phase 4 (Final)

Fully open  
Within limits of local mandates  
COVID precaution not required

Letter to the Kingdom from Crown

Board announced re-opening  
Does not begin until 1st of June  
Still in Gated Phase  
No in person events/practices  
Kingdom will announce when change in phase happens  
Via Kingdom webpage, Outlandish Herald, appropriate Media pages  
If you are healthcare professional  
Want to help with setting protocols/training  
Contact Kingdom seneschal  
Due to no camping and 150 cap for attendance  
Battlemoor is postponed until 2022  
Rules of re opening are for safety  
Not willing to risk life of a single populace member  
Will be strictly enforced  
If can not or will not follow the rules  
Please stay home  
If at an event, will be asked to leave  
If you don't leave= event immediately cancelled & closed

There is a light at the tunnel's end

Stay the course  
Social distance  
Wear masks  
Practice good hygiene

Discussed need to purchase thermometers and disposable masks for events. Exchequers will work on procuring  
Temperature checks will be conducted by officers
