Homeowner solely responsible

Enforcement of requirement

Determining what proof is required

Checking proof

Masks & social distancing still required

BOD has not created different condition for participation based upon vaccination status

Prior to using any rented/contracted site requiring COVID vaccinations Contact Society seneschal

No blanket approval will be given by kingdom

Will need to petition for each practice/event

Due to status in constant state of flux

Use most restrictive guidelines of any zip codes in your area

Mean particular zip code only

If a person outside zip code attends

Changes from a practice/meeting to an event

Would need a variance for those outside zip to attend

No sharing of food

Unless it is an emergency

Must be commercially sealed

Only allowed outdoor events

Indoor bathroom at an event is acceptable

Contact tracing

Responsibility of health dept., not SCA

Still require a list of attendees (per norm)

Health Info

No temperatures checks

Unless mandated by local governing bodies/ site

Should this be necessary then have to let Kingdom

Seneschal know how info will be collected

No form to petition crown at this time

Do not submit petitions until we are in Phase 1 of re-opening

All info will change before opening

Status/procedures are in flux

BOD still moving slowly

Pre-registration

Kingdom seneschal working with web minister for pre-reg system BOD is vague about pre-reg

Can sign up on Facebook

Sign in once at the event/practice

Attendees

Limited to 150 (even if local allows more)

Society ruling
