The event site is an indoor track and field arena with electricity, heat/cooling, water, and restrooms. NO FOOD OR DRINK OTHER THAN WATER IS ALLOWED IN THE BUILDING. Traditional seating will be limited - please feel free to bring your own chair. There are comfortable landing mats available for use, as an alternative.
